**It may be noted that no candidate under O.B.C. B (E.C.) category applied for the post of English Stenographer; hence the vacancy against O.B.C. B (E.C.) category could not be filled up and remains vacant.**

The Selected Candidate shall be guided by the following norms and conditions, as resolved by the District Recruitment Committee, Uttar Dinajpur Judgeship :-

1. The Selected candidate, as mentioned above shall be appointed purely on temporary basis and shall remain on probation for the period as provided in “**The West Bengal District Court (Constitution of Service, Recruitment, Appointment, Probation and Discipline of Employees) Rules, 2015**” & during his/ her period of probation, if it is found that the candidate is not fit for the post, then his/ her period of probation shall not be extended and he/ she will be removed from the service, automatically.
2. The candidate selected above, if already in Government Service whether in any Judgeship or in any Department of West Bengal or Union of India or any PSU, shall submit “No Objection Certificate” along with a certificate issued by his/ her Appointing Authority showing that there is no disciplinary proceeding pending against him/ her for the charge of corruption, insubordination or for any other reason and there is no criminal case arising out of his/ her rendering present service, pending or any other proceeding/s pending against him/ her.
3. **The Candidate selected above shall have to appear before the Medical Board in the Office of the Medical Superintendent-cum-Vice Principal of the District on 07.10.2024 with his/ her individual reports of Blood RE, Urine RE, ECG, Blood Sugar PP and fasting. The Pathological Reports must be done after the date of publication of the instant panel at any Government registered Pathological Laboratory or Government Hospitals.** The Candidate has also to collect TR Form No. 7 (5 copies) from the Office of the Medical Superintendent-cum-Vice Principal of the District and has to make necessary payment at SBI, Karnojora Branch after obtaining necessary endorsement from the Office of the MSVP of the District, on 07.10.2024
4. **The above selected candidate shall download and take print out (03 copies) of the blank Police Verification Roll which will be sent to him through email message at his registered email ID and is to submit duly filled up Police Verification Roll (03 copies) along with attested copy of his/ her Educational Qualification within 07.10.2024 to the Office of the District Judge, Uttar Dinajpur at Raiganj. Suppression of any educational qualification or any other information by the candidate during submission of the Police Verification Roll may lead to removal of his/ her name from the above panel. *He/ she must obtain necessary endorsement on the counterpart of his/ her Admit Card from the Office of the District Judge, Uttar Dinajpur at Raiganj at the time of collection of Police Verification Roll in regard to his/ her selection for appointment.***

5. **In case of non-submission of the Police Verification Roll and non- appearance before the Medical Board on 07.10.2024, it will be treated that the candidate is not willing to join his/ her post and his/ her name will be deleted from the list of selected candidate.**
6. The Appointing Authority shall reserve the right to de-list any candidate from the list of selected candidate, if it is found that for any other reason the candidate is not eligible for the post.
7. The selected candidate above will be issued Appointment Letter on receipt of satisfactory report on Police Verification Roll and Medical Fitness from the authorities concerned.
